- All new artists must schedule an appointment and bring samples to the Westtown Association office for approval. Only approved items may be sold at the market. Appointments can be scheduled by calling (414) 276-6696.
- This form is an application to be considered for participation in the event. Filling out the application does not guarantee acceptance for participation.
- All vendors are asked to furnish a copy of their Wisconsin Seller's Permit or social security number. Market staff will provide vendor information to the Department of Revenue in accordance with all state laws. For information on the Wisconsin Seller's Permit, please call the Wisconsin Department of Revenue at (608) 266-2776.
- Art vendor fees are \$250 for the 8-day season (11/4, 11/18, 12/2, 12/16, 1/6, 1/20, 2/3 2/17). We strongly encourage you to commit to the entire season. Seasonal fees are due by October 16th and will be accepted by the order in which they were received. A \$50 rebate will be returned at the end of the season to all seasonal vendors (that paid \$250) who have perfect attendance at the market. Perfect attendance means your stall has been open for business on each of the eight market days. Absences will not be excused unless a snow emergency is declared by the City of Milwaukee and/or The Shops of Grand Avenue fails to open on the day of a market.

PLEASE READ CAREFULLY BEFORE SIGNING APPLICATION:

Selling privileges at the Westtown Indoor Market are extended to bonafide artists for the sale of work that they have personally made and which has been specifically approved for sale by the Westtown Association.

I have read and understand the rules and regulations of the Westtown Indoor Market. I agree to abide by these rules and regulations and the authority of the Westtown staff. I understand that selling must be done under proper state and local licensing and that procurement of such licenses is my responsibility.

I agree to protect, indemnify, and hold harmless the Westtown Association, The Shops of Grand Avenue and the City of Milwaukee from and against any and all causes of actions, claims, demands, suits, liability or expense by reason of loss or damage to any property or bodily injury to any person, including death, as a direct or indirect result of the use of any rented or occupied market space or in connection with any action or omission of the renter who shall defend the Westtown Association, The Shops of Grand Avenue, or the City of Milwaukee in such cause of action or claim.
